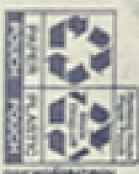
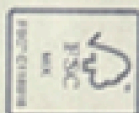

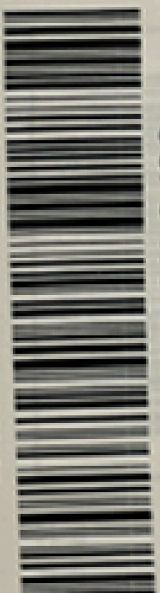

Re: The Name of My Standby Counsel in the 16-CR-100-PP "Bakley" Case

Judge Pepper:

I am requesting you provide me with the name of the attorney who served as my standby counsel in the 16-CR-100-PP "Bakley" case.

As you are aware, attorneys Christopher Donovan ("Donovan") and Martin Pruhs ("Pruhs") have twice stated, once in an email (~~Exhibit 1~~), and once in a response to a Complaint filed with the Wisconsin Supreme Court, Office of Lawyer Regulation (~~Exhibit 2~~) that, they were not my attorneys in the 16-CR-100-PP "Bakley" case, and/or, were not appointed to represent me in that case.

[Exhibits intentionally omitted to avoid duplication.]

You state in your rulings that I had standby counsel.

I ask that you identify, if not Donovan or Pruhs, who is the attorney that served as my standby counsel that you make reference to in your 16-CR-100-PP "Bakley" case rulings.

I have spent seven and a half years in Federal prison serving time on this case, and not seen my children for the same period of time.

If I had no attorney in your 16-CR-100-PP "Bakley" case, and there was no Faretta colloquy performed establishing a voluntary, knowing, and intelligent waiver of counsel following my June 28, 2016 indictment and July 14, 2016 arraignment that would be a huge issue.

As you know, a waiver made nine months prior in a separate case, before a different Court doesn't fly.

As you have probably surmised Judge Pepper, I am not going to relent. I believe I was wronged, and am going to continue. You should also realize that, this issue, as it gains traction and is seen by more and more attorneys and regulators they are going to wonder why you won't just provide me with the name of the attorney that represented me that you made reference to in your rulings.




